**About the 2011 ISACA Shopping on the Job Survey: Online Holiday Shopping and BYOD Security**

The ISACA Shopping on the Job Survey: Online Holiday Shopping and BYOD Security, now in its fourth year, helps gauge current attitudes and organizational behaviors related to the risk and rewards associated with online shopping, and the blurring boundaries between personal and work devices. The study is based on October 2011 online polling of 4,740 ISACA members from 84 countries, including 298 members from India. A separate online survey was fielded among 1,224 US consumers by M/A/R/C Research between 27 September and 30 September 2011. At a 95 percent confidence level, the margin of error for the total sample is +/- 2.8 percent.
