2. The registration for the **ISACA CISA Exam Preparation Training** must be done via ISACA Belgium Chapter in Brussels (www.isaca.be).

A combined registration is not possible!

IMPORTANT RECOMMENDATIONS

- **TRAVELLERS ARRIVING BY PLANE AT BRUSSELS AIRPORT:** From the airport Brussels Zaventem to Brussels Midi train station is around 20 minutes train ride at 8.50 euro per person.
- **TRAVELLERS BY TRAIN FROM FRANCE, UK, THE NETHERLANDS, GERMANY:** The hotel is next to the Brussels Midi train station with direct access to the EUROSTAR, TGV, THALYS and ICE train.
- **TRAVELLERS USING BRUSSELS METRO:** The hotel is next to the Brussels Midi train station with direct access to the MIVB underground (metro) via line 2 and 6.

Transportation:

On Friday afternoon after the training (around 17:00), you can take the train from Brussels Midi directly to the Brussels airport in less than 30 minutes.
