Hello fellow ISACA® New York Metro members:

The Board of Directors held its first meeting of the fiscal year last month and we're all very excited about the year ahead. We've outlined several strategic initiatives which we think will greatly add to your membership experience.

First, we are revamping our already outstanding membership and education plan. The plan will include more strategic events (e.g. round-tables, and events targeted to a particular member level). In fact, we are holding an invitation-only Cybercrime roundtable where the former US Attorney General, Michael Mukasey, will be one of the panelists discussing new and emerging threats in this arena. This event is targeted to senior executives from our memberships in Info-Security and General Counsels. We are planning similar events later this year.
